### ARE ALL DONATIONS TAX DEDUCTIBLE?

The Trustee for the St Andrew's Hospital Foundation Charitable Trust is a registered deductible gift recipient (DGR) with the Australian Taxation Office. All donations \$2 and over are tax deductible.

### WHAT SORT OF BEQUEST CAN I MAKE?

Bequests can be made in a variety of ways to assist our work and to suit your personal preferences. For example, you may wish to bequeath a residual share of your estate, part of the value of your estate, a specified sum of cash, or a gift of stocks, bonds or other assets.

#### DO I NEED TO WRITE A NEW WILL TO MAKE A BEQUEST?

No. You can simply add a clause (a codicil) to your existing Will.

#### **DOES THE ST ANDREW'S HOSPITAL** FOUNDATION REQUIRE A COPY OF MY WILL?

No. We simply record that you have expressed your wishes in your Will and record your contact details.

If you are interested in making a bequest or gift to St Andrew's Hospital Foundation in your Will, we suggest that you also seek professional advice from your legal advisor to accurately reflect your own wishes.

In discussion with your legal advisor, you may wish to bequest a specific amount of money or a percentage of your estate. A general clause in your testimony could therefore state either;

"I give the sum of \$X to The Trustee for the St Andrew's Hospital Foundation Charitable Trust of 350 South Terrace, Adelaide SA 5000. I declare that the receipt of the Chief Executive Officer of the Hospital shall be sufficient discharge to my executor and/or Trustee who shall not be bound to see the application of my gift".

"I give X percentage of the residue of my estate to The Trustee for the St Andrew's Hospital Foundation Charitable Trust of 350 South Terrace. Adelaide SA 5000. I declare that the receipt of the Chief Executive Officer of the Hospital shall be sufficient discharge to my executor and/or Trustee who shall not be bound to see the application of my gift".
